Grant of Options

White Cliff Minerals Limited (ASX: WCN) advise that it has today allotted 32,500,000 unlisted Options exercisable at 6 cents on or before 30 September 2014.

The Options have been granted to participants of the Company's recent placement (12,500,000 Options) and shareholder purchase plan (10,000,000 Options). The terms of both offers included one free option for every two shares placed. Both offers were fully subscribed and the Company successfully raised \$750,000 via a private placement and \$600,000 via a shareholder purchase plan completed in early October.

In addition 10,000,000 Options were allotted to directors, employees and consultants following shareholder approval at the Company's recent AGM.

Any shares which are issued as a result of the exercise of these Options will rank pari-passu in all respects with all shares on issue, and the Company will apply for quotation of those shares on the ASX.
